



Importing Personal Property Into **BANGLADESH**

IMPORTING HOUSEHOLD GOODS/ PERSONAL EFFECTS AND MOTOR VEHICLES

DUTY-FREE ENTRY IS PERMITTED IF THE FOLLOWING REQUIREMENTS ARE MET:

- The shipper has diplomatic status or is a "Privileged Person". A "Privileged Person" is an employee of a UN agency, an NGO or a foreign company that has a contract which specifically states that employees are privileged.
- Other foreigners and returning Bangladeshis, are allowed importation of household goods, but will be subject to duty, tax and V.A.T.

Important Notes:

- The shipper must be present in Bangladesh during the time of customs clearance.
- The household goods shipment must arrive within 6 months of the shipper's arrival.
- It is important not to mix household goods/ personal effects with commercial goods in your shipment. Office furniture, stationery and office machines are considered commercial goods.

REQUIRED DOCUMENTS

- ✓ Original passport for shipper and all family members.
- ✓ Itemized valued inventory, listing all electrical items separately, listing brand, model and serial number.
- ✓ Form A, obtained from Customs at airport during arrival.
- ✓ Transfer of Residence Form
- ✓ Certificate of employer

PROHIBITED ITEMS

- Drugs and narcotics
- Pornographic or subversive literature
- Ammunition and firearms
- Gold bullion
- Construction material in commercial quantity.
- Gambling instruments

RESTRICTED ITEMS

- Drugs
- Pornographic or subversive literature
- Ammunition and firearms
- Gold bullion
- Gambling instruments

RESTRICTED ITEMS

- Alcohol, tobacco and food.
- Hunting guns are restricted, but may be imported if proper and prior declaration is obtained (see below).
- Antiques, sterling silver and gold should be declared to facilitate re-export.

IMPORTATION OF MOTOR VEHICLES

- Vehicles must be less than 6 years old and right-hand drive.

REQUIRED DOCUMENTS

In addition to the documents required for a household goods shipment:

- ✓ Invoice
- ✓ Registration
- ✓ Ownership Certificate

IMPORTATION OF DOGS AND CATS

- Domestic dogs and cats may be imported.

REQUIRED DOCUMENTS

- ✓ Prior permission from the Director of Livestock, Government of Bangladesh
- ✓ A health certificate from a veterinarian is recommended.

IMPORTATION OF HUNTING GUNS

- Importation is permitted if the proper and prior declaration is conducted by the shipper.
- Customs clearance is subject to issuance of a gun license from the Bangladesh Government.

REQUIRED DOCUMENTS

- ✓ Gun License issued by the Bangladesh Government.
